INCENTIVES

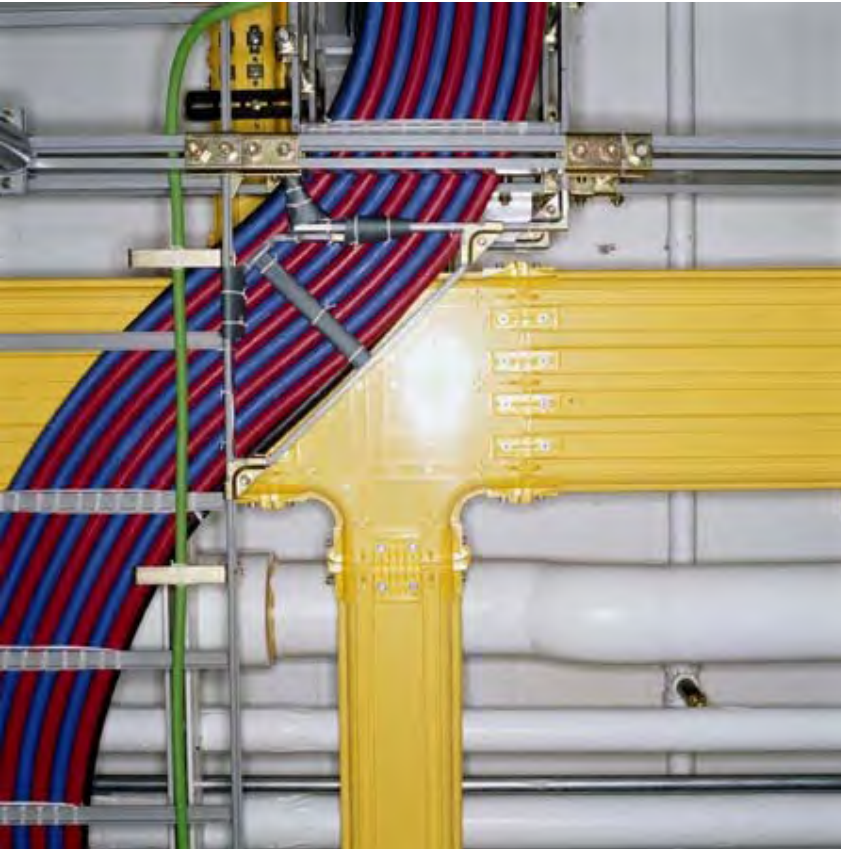
Incentives are based on the energy saved over the course of one year.

- \$0.10 per kWh saved
- \$1.00 per therm saved

One-time payment at the conclusion of the project

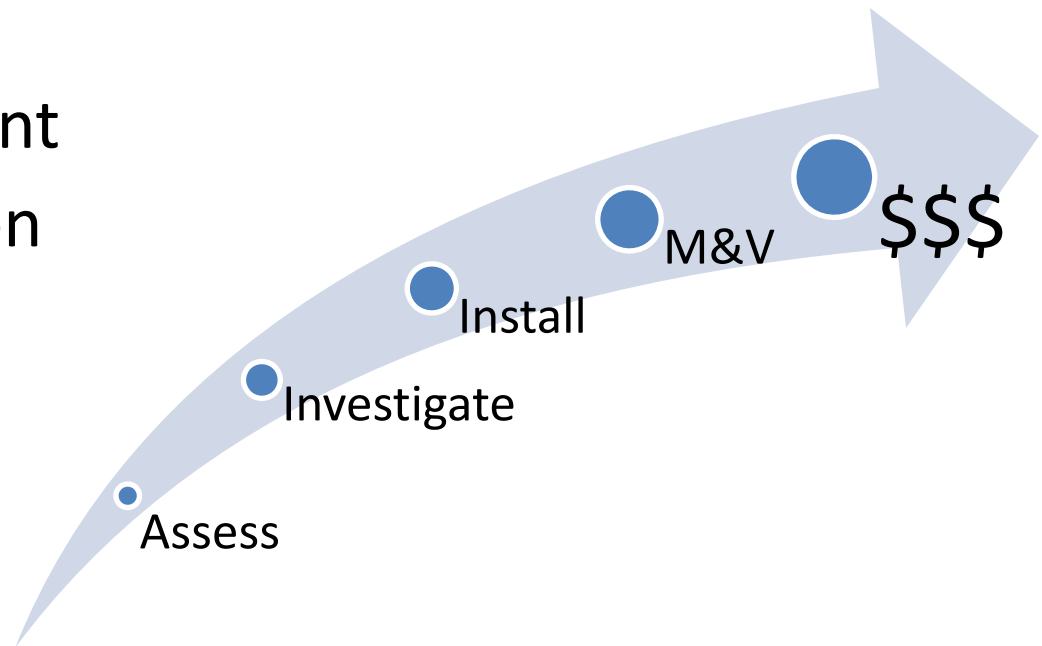
Eligible opportunities include*:
